What is this product? 本基金是甚麼產品？

The Fund is a sub-fund of Capital International Fund, which is a mutual fund domiciled in Luxembourg and its home regulator is the Commission de Surveillance du Secteur Financier (“CSSF”).

本基金是 Capital International 基金的子基金，Capital International 基金是設於盧森堡的互惠基金，其當地監管機構是盧森堡金融業監管委員會(Commission de Surveillance du Secteur Financier)(「盧森堡監委會」)。

Objectives and investment policy 目標及投資政策

The Fund seeks to provide, over the long term, a high level of total return largely comprised of current income consistent with capital preservation and prudent risk management. Preservation of capital is not guaranteed.

The Fund invests primarily in USD-denominated corporate Investment Grade Bonds¹. The Fund seeks to invest at least 80% of its total net assets in corporate bonds. Investment in bonds will be limited to Investment Grade Bonds. All securities held by the Fund will be denominated in USD. The Fund may invest in securities of issuers from any country. These are usually listed or traded on other Regulated Markets². Such investments in Regulated Markets may include unlisted securities and other fixed-income securities (such as government securities) which are traded over-the-counter.

The Fund will only invest in Investment Grade Bonds at the time of purchase. If an Investment Grade Bond fails to maintain an Investment Grade rating from at least one rating agency (or which are no longer deemed Investment Grade by the Investment Adviser), such bond must be sold within six months from its downgrading, taking into account the interests of the Fund’s shareholders.

The Fund may invest in mortgage- and asset-backed securities, credit-linked notes and similar instruments of a credit rating no lower than Investment Grade, such investments not to exceed 10% of the net asset value of the Fund and provided that the issuer is either located in a member state of the OECD or an European Economic Area country and/or the assets are admitted to trading on or included in a regulated market.

The Fund may invest up to 35% of its total net assets in debt securities issued and/or guaranteed by a single sovereign issuer (including its government, public or local authority) from any country such as the United States. Such investments are based on the professional judgement of the Investment Adviser and/or the Investment Sub-Adviser (together, the “Investment Advisers”) whose reasons for investment may include a favourable/positive outlook on the relevant sovereign issuer, potential for ratings upgrade and expected changes in the value of such investments due to the ratings changes.

The Fund does not enter into securities lending, repo, reverse repo or other similar over-the-counter (OTC) transactions. The Fund may use financial derivative instruments for investment purposes, hedging and/or efficient portfolio management. Instruments permitted are interest rate swaps, credit default swap indices, credit default swaps, forward contracts, foreign exchange options, futures and options on futures as described in more detail in the main part of the Prospectus under the “Risk Warnings” section and in Annex 1 of the Prospectus.

Up to 10% of the total net assets of the Fund may be subject to Total Return Swaps.

In order to achieve its investment goals, for treasury purposes and/or in case of unfavourable market conditions, the Fund may also invest in deposits with credit institutions, money market instruments and units of money market funds. For defensive purposes, the Fund may hold also up to 100% of its net assets in these instruments on a temporary basis.

The Fund aims to manage a carbon footprint (weighted average intensity, “WACI”) for its investments in corporate issuers that is lower than the Bloomberg U.S. Corporate Investment Grade index. While this Fund is actively managed and without any reference or constraints to a reference index, the Fund is using the Bloomberg U.S. Corporate Investment Grade index to monitor the investment’s carbon emission. Should the WACI of the Fund not be lower than the level of the Fund’s selected index, the Investment Adviser will consider what action is in the best interest of the Fund, its Shareholders and in line with the relevant Fund investment objective to bring the Fund’s WACI back to a level that is below the WACI of the aforementioned index in a reasonable period of time. The Investment Adviser also evaluates and applies Environment, Social and Governance (“ESG”) and norms-based screening to implement exclusions at the time of purchase relating to the Fund’s investments on corporate issuers, with respect to certain sectors such as fossil fuel and weapons.

The Fund commits to maintain at least 10% of its investment in sustainable investments.

- ¹ “Investment Grade Bond”, for the purposes of the Fund, refers to (i) a bond which has been (or which is issued by an issuer which has been) assigned an investment grade³ credit rating; or (ii) an unrated⁴ bond deemed to be of equivalent standing by the Investment Advisers. In the case of a split-rated security, the highest credit rating of Standard & Poor’s, Fitch or Moody’s will generally apply. In order to determine whether an unrated debt security is of equivalent quality, the Investment Advisers will look at the creditworthiness of the issuer of such unrated debt security. The Investment Advisers will evaluate not only an issuer’s ability to repay their debt, but will also determine whether the pricing of such debt appropriately reflects the issuer’s ability to repay.
- ² “Regulated Market”, for the purposes of the Fund, means a market that is regulated, operating regularly, recognised and open to the public. In the case of bonds, Regulated Markets include (i) the Over-the-Counter-Markets of the NASDAQ System; (ii) the Over-the-Counter Market of the members of the International Capital Market Association; (iii) the US NASD-regulated Over-the-Counter Bond Market; and (iv) any similarly operating regulated market on which bonds including Eurobonds and similar off-shore bonds are customarily dealt in.
- ³ “Investment grade”, for the purposes of the Fund, refers to a credit rating equal to or better than BBB- by Standard & Poor’s or Fitch, or Baa3 by Moody’s.
- ⁴ An “unrated” security, for the purposes of the Fund, refers to a security where neither it nor its issuer has been assigned any credit rating by Standard & Poor’s, Fitch or Moody’s.

本基金力求在貫徹保本及審慎風險管理之下，長遠而言提供高度的總回報，其中大部分是經常收益。保本不獲保證。

本基金主要投資於以美元計值的公司投資級債券¹。本基金力求最少以其總淨資產的80%投資於公司債券。債券的投資以投資級債券為限。本基金持有的所有證券將以美元計值。本基金可投資於任何國家的發行人的證券。這些證券通常在其他受規管市場²上市或買賣。該等在受規管市場的投資可包括非上市證券及其他在場外買賣的定息證券（例如政府證券）。

本基金只會投資於在購入時屬投資級的債券。若投資級債券未能維持其從至少一間評級機構所獲的投資級評級(或投資顧問不再視之為投資級)，在顧及本基金股東利益的情況下，該債券必須於其評級被調降後六個月內予以出售。

本基金可投資於按揭及資產抵押證券、信貸掛鈎票據及信貸評級不低於投資級的同類工具，該等投資不得超出其資產淨值的 10%，而且發行人須位於經合組織成員國或歐洲經濟區國家及／或有關資產須獲准在受規管市場買賣或被納入受規管市場。

本基金最多可以其總淨資產的35%投資於由任何國家(例如美國)的單一主權國發行人(包括其政府、公共或地方當局)發行及/或擔保的債務證券。上述投資以投資顧問及/或副投資顧問(合稱「各投資顧問」)的專業判斷為依據，其投資的理由可包括相關主權國發行人的前景有利/正面，評級有調升的潛力及該等投資的價值預期會因評級變更而改變。

本基金並不進行證券借貸、回購、反向回購或其他類似的場外(OTC)交易。本基金可運用金融衍生工具作投資目的、對沖及／或有效投資組合管理。獲准工具為利率掉期、各信貸違約掉期指數、信貸違約掉期、遠期合約、外匯期權、期貨及期貨期權，詳見發行章程主文內「風險警告」一節及附件一。

本基金總淨資產的最多10%可用以訂立總回報掉期。

為達致其投資目標、用作財務用途及／或在不利市場狀況下，本基金亦可投資於信貸機構的存款、貨幣市場工具及貨幣市場基金的單位。本基金亦可暫時持有最多100%的淨資產於該等工具，以作防禦用途。

本基金旨在管理其投資於企業發行人的碳足跡（加權平均碳密度，「加權平均碳密度」）為低於彭博美國企業投資級別指數。儘管本基金以主動式管理及沒有對參考指數作出任何參考或受其限制，惟本基金正使用彭博美國企業投資級別指數監控投資的碳排放。倘若本基金的加權平均碳密度不低於本基金所選指數的水平，投資顧問將考慮採取何等行動乃符合本基金、其股東的最佳利益，並符合相關基金的投資目標，以使其加權平均碳密度在合理的時間內恢復到低於上述指數的加權平均碳密度的水平。就化石燃料及武器等若干行業而言，投資顧問亦評估及應用環境、社會及管治（「ESG」）和規範為本篩選，以在購買時就本基金對企業發行人的投資落實排除。

本基金承諾維持其至少10%的投資於可持續投資。

- 1 就本基金而言，「投資級債券」指(i)信貸評級獲評定為投資級³(或由獲評定為投資級³的發行人所發行)的債券；或(ii)各投資顧問視作同級的無評級⁴債券。如屬分割評級證券，一般將適用由標準普爾、穆迪或惠譽所評定的最高信貸評級。為了確定無評級的債務證券是否具有同等質素，各投資顧問將檢視該無評級債務證券發行人的信用可靠性。各投資顧問不但會評估發行人償還債務的能力，亦會確定該項債務的定價是否適當地反映發行人的還債能力。
- 2 就本基金而言，「受規管市場」指受規管、定期運作、獲認可及向公眾開放的市場。就債券而言，受規管市場包括(i)納斯達克系統的場外交易市場，(ii)國際資本市場協會成員的場外交易市場，(iii)受美國NASD規管的場外交易債券市場，及(iv)任何以類似方式運作，通常買賣債券(包括歐元債券)及類似離岸債券的受規管市場。

What are the key risks? 本基金有哪些主要風險？

1. General investment risk

- The Fund's investment portfolio may fall in value due to any of the key risk factors below and therefore your investment in the Fund may suffer losses. There is no guarantee of the repayment of principal.

2. Bonds/debt securities risk

- The Fund is exposed to the credit/default risk of issuers of the bonds and other debt securities in its portfolio. The market value of bonds generally vary inversely with the level of interest rates – when interest rates rise, their values will tend to decline and vice versa.
- The credit rating of a debt security (or its issuer), including an Investment Grade Bond, may subsequently be downgraded. In the event of such downgrading, the value of the Fund may be adversely affected. The Investment Advisers may or may not be able to dispose of such downgraded securities at favourable prices or at all.
- Credit ratings assigned by rating agencies are subject to limitations and do not guarantee the creditworthiness of the security and/or the issuer at all times.
- The Fund's investment in securities issued or guaranteed by governments may be exposed to political, social and economic risks. In adverse situations, the sovereign issuers may not be able or willing to repay the principal and/or interest when due or may request the Fund to participate in restructuring such debts. The Fund may suffer significant losses when there is a default of sovereign debt issuers.

3. Risk associated with debt securities which are unrated

- The Fund may invest in unrated debt securities which are deemed to be of equivalent standing to Investment Grade Bonds by the Investment Advisers. Such unrated debt securities may be subject to lower liquidity, higher volatility and greater risk of loss of principal and interest than rated debt securities.

4. Valuation risk

- Valuation of the Fund's investments may involve uncertainties and judgemental determinations. If such valuations are incorrect, this may affect the net asset value calculation of the Fund.

5. Liquidity risk

- Some securities, primarily unlisted securities and/or those traded in over-the-counter markets (for example, unlisted debt securities), may be subject to lower liquidity. The prices of such securities may be subject to higher fluctuation compared

with securities listed on a recognised stock exchange. Bid and offer spreads may be large and the Fund may incur significant trading costs.

6. Counterparty risk

- Other financial institutions provide services to the Fund such as safekeeping of assets or may serve as counterparties to financial contracts such as derivatives. There is a risk a counterparty will not meet its obligations and/or default.

7. Currency hedged share classes risk

- The currency hedging process used with currency hedged share classes may not give a precise hedge and there is no guarantee that hedging will be totally successful. Returns of such classes may be significantly different over time than those of unhedged classes and the hedging may limit the ability of these classes to benefit from the currency diversification undertaken within the Fund's portfolio. Hedging at the Fund level will preclude investors from benefitting from appreciation of the non-USD currencies against USD, the base currency of the Fund. Investors in currency hedged classes bear the associated costs and may also be exposed to the risks associated with the instruments used in the hedging process.

8. Derivative instruments risk

- While the Fund uses derivative instruments in a prudent manner and for investment, hedging and/or efficient portfolio management purposes, derivative instruments may expose the Fund to additional risks related to the credit risks of the counterparty and potential for increased volatility and reduced liquidity in comparison to the underlying security positions. Derivatives are also subject to valuation risk, over-the-counter transaction risk, operational risk and legal risk and any leveraging effect can result in a loss significantly greater than the amount invested in the derivative by the Fund. Exposure to derivatives may lead to a high risk of significant loss by the Fund.

9. Dividend risk and distribution out of/effectively out of capital risk

- There is no assurance that dividends will be declared and paid in respect of the underlying investments held by the Fund. The rates of dividend payment in respect of such securities may be affected by factors beyond the control of the Management Company.
- Dividend-distributing equivalent classes with a fixed dividend policy will distribute the dividends based on a fixed amount (in respect of classes targeting a fixed DPS amount, if any) or based on a fixed percentage of the net asset value per share (in respect of classes targeting a fixed dividend yield (expressed as a percentage)), if any). Investments in Dividend-distributing equivalent classes with a fixed dividend policy are not an alternative to a savings account or fixed-interest paying investment and the level of dividends is unrelated to past dividend distributions of these share classes or the Fund. Dividend-distributing equivalent classes with fixed dividend policy may either be paying out both income and capital in dividend payments, or not substantially distributing all the investment income which a class has earned. The dividend can thus be higher or lower than the income and return that were effectively realised and may exceed the gross investment income of these classes of the relevant Fund.
- In circumstances where dividends are paid out of and/or effectively out of the Fund's capital, this amounts to a return or withdrawal of part of an investor's original investment or from any capital gains attributable to that original investment. Any such distributions may result in an immediate reduction of the net asset value per share of the relevant class.

10. Sustainability risk

- Sustainability risks refer to an environmental, social or governance event or condition that, if it occurs, could cause an actual or a potential material negative impact on the value of the investments of a Fund. Sustainability risks for the Fund (and/or companies in which the Fund invests in) may include, but are not limited to, the following: climate change risk where, depending on the Fund's operational footprint, increased exposure to physical climate risks such as extreme weather events create a more volatile operating backdrop for companies and put countries growth under pressure; data security risk where vulnerability to data theft or leakage could have a significant impact on consumer trust and result in a loss of market share for companies, and the associated repercussions; governance risks where shortcomings in board composition, independence, ethical standards or shareholder rights protection could lead to unanticipated losses for a company; human capital risks; supply chains risks; lobbying and business ethics risks which pose regulatory and financial

risks; risks from exposure to historic controversies; and other and emerging sustainability risks. The Fund's asset value may be adversely affected as a result of the above mentioned risks.

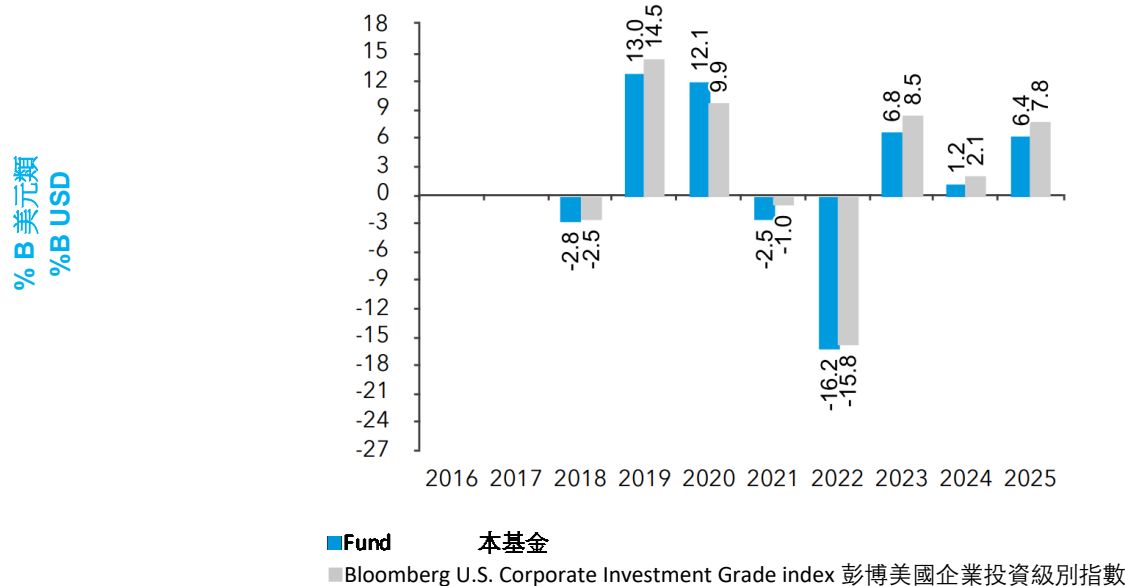
