### OBJECTIVES AND INVESTMENT POLICY

#### Objective

- Long term growth of your investment

#### Main Investments

- At least 70% of the Fund's investments will be in company shares, including depositary receipts.

#### Investment Policy

- To invest in "Next Gen" companies, being defined as companies based in or carrying out most of their businesses in emerging market countries, which include frontier market countries, or upcoming developing markets outside the "mainstream" emerging markets whose capital markets have traditionally been difficult for foreign investors to access or are in the early stages of capital market and/or economic development.
- The Fund includes climate- and weapons-related exclusions alongside other sector/industry restrictions, including, tobacco, adult entertainment and gambling. - The Fund will measure its performance against the MSCI Frontier Emerging Markets Net Index (the "Benchmark"). The Fund is actively managed and is not designed to track the Benchmark. Therefore, the management of the Fund is not constrained by the composition of the Benchmark.

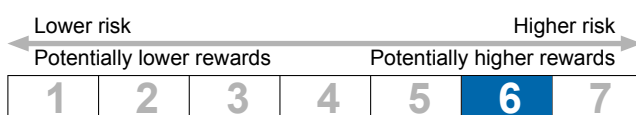
#### Other Information

- The Fund references third-party ESG data during the security research process, but uses its own proprietary analysis for security selection and portfolio construction. Where data on specific issuers or exclusions is not available, the Investment Adviser may use reasonable estimates or third-party data, where available.
- The Fund may invest in derivatives, which are financial instruments that take their value indirectly from other assets, for investment or efficient portfolio management purposes. They rely on other companies to fulfil contractual obligations and carry more risk. Refer to the prospectus ('Financial Derivative Instruments' section) for more details.
- Income may be paid bi-annually in cash or additional shares.
- The Fund may invest up to 30% of its assets in investments that do not meet the above criteria.

#### Buying and selling shares

- Investors may buy and sell shares on every full banking business day in Luxembourg.

### RISK AND REWARD PROFILE

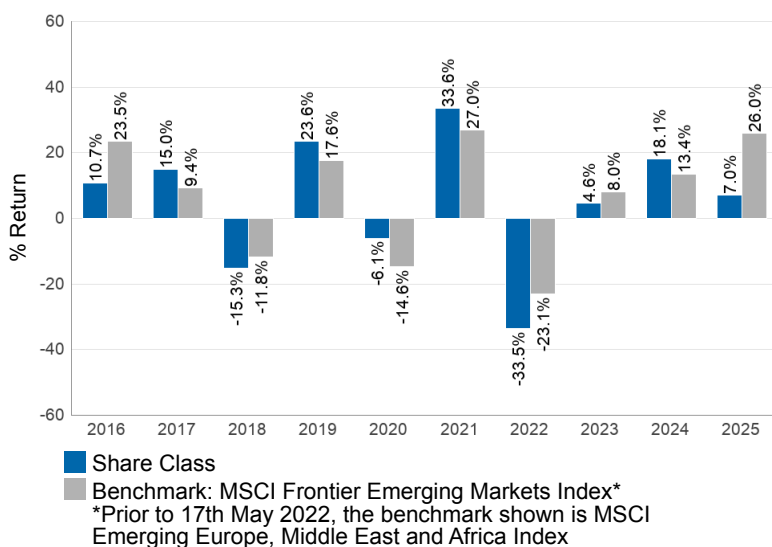
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
