OBJECTIVES AND INVESTMENT POLICY

Objective

- Long term growth of your investment

Main Investments

- At least 70% of the Fund's investments will be in company shares, including real estate investment trusts.

Investment Policy

- To invest in companies based anywhere in the world, that are involved in the infrastructure business. For example road building and maintenance, operating airports, distributing electricity etc. Where funds and trusts are used the investor may indirectly bear the ongoing management costs of those investments as well.
- The sub-investment manager uses fundamental analysis to identify companies whose securities may offer the best return potential based on a multi-layered filtering process. The sub-investment manager actively integrates sustainability into the investment process by assessing key ESG risks and opportunities in the bottom-up stock selection process by leveraging third party ESG data providers to assess and quantify ESG performance for issuers, informing position sizing; increasing allocation to those companies with more favourable ESG ratings.
- The Fund includes tobacco, adult-entertainment, gambling and weapons-related exclusions and restrictions on companies associated with severe ESG controversies without material remediation and improvement. - The Fund will measure its performance against the Dow Jones Brookfield Global Infrastructure Index (the "Benchmark"). The Fund is actively managed and is not designed to track the Benchmark. Therefore, the management of the Fund is not constrained by the composition of the Benchmark.

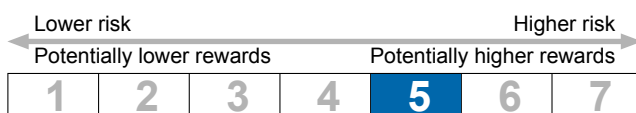
Other Information

- The Fund may invest up to 30% of its assets in investments that do not meet the above criteria.
- This is a currency hedged share class. It aims to reduce the impact on your investment of movements in the exchange rate between the fund currency and the share class currency.
- Income will be included in the value of your shares.

Buying and selling shares

- Investors may buy and sell shares on every full banking business day in Luxembourg.

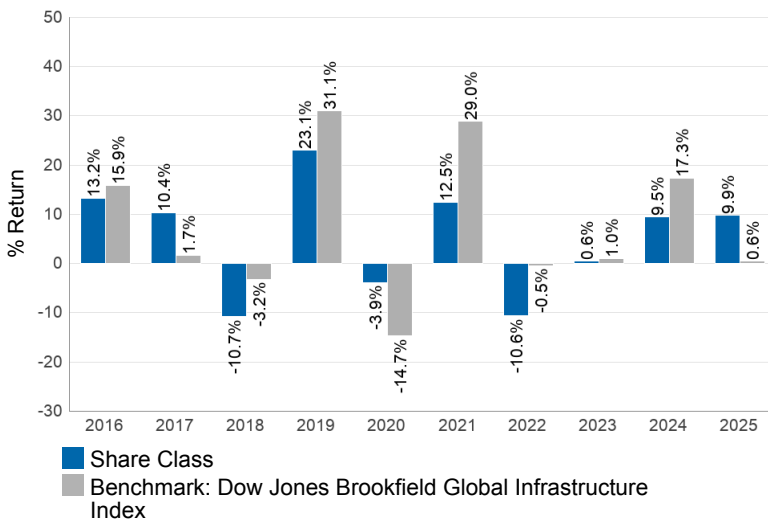
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
