OBJECTIVES AND INVESTMENT POLICY

Objective

- To provide an attractive rate of relative return, while seeking to reduce the Fund's exposure to market interest rate movements.

Main Investments

- At least 70% of the Fund's investments will be in fixed income securities (e.g. bonds).

Investment Policy

- To invest in high quality Euro denominated fixed income securities issued by corporations and other non-government related issuers. Bonds are high quality if they are rated BBB- or better by S&P or Baa3 or better by Moody's. The Fund utilises duration hedging strategies that aim to reduce the risk of a movement in interest rates affecting your investment.
- As an essential and integrated part of the research process and through engagement with issuers, the Investment Adviser incorporates an assessment of sustainability related risks and opportunities into the assessment process.
- The Fund includes tobacco, climate- and weapons-related exclusions, the details of which may be found in the Fund's Restriction Screening policy on the Company's website (www.morganstanleyinvestmentfunds.com and at www.morganstanley.com/im).
- The Fund is actively managed and the management of the Fund is not constrained by or compared to a benchmark.

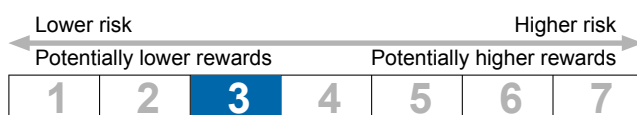
Other Information

- The Fund may invest up to 30% of its assets in other fixed income securities that do not meet the above criteria, for example bonds not issued in Euro.
- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets. They rely on other companies to fulfil contractual obligations and carry more risk. Refer to the prospectus ('Financial Derivative Instruments' section) for more details.
- Income will be included in the value of your shares.

- Investors may buy and sell shares on any Luxembourg business day.

RISK AND REWARD PROFILE

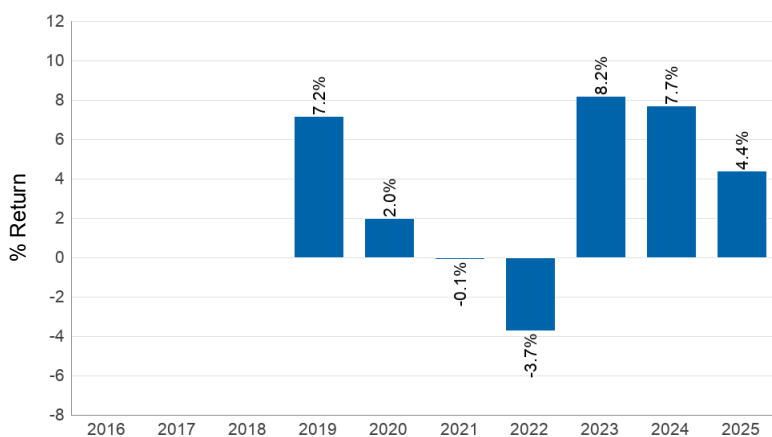
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
