#### OBJECTIVES AND INVESTMENT POLICY

##### Objective

- Long term growth of your investment

##### Main Investments

- At least 70% of the Fund's investments will be in company shares.

##### Investment Policy

- To invest in large companies based in or carrying out most of their business in the US.
- As an essential and integrated part of the investment process, the Investment Adviser assesses relevant factors material to long-term sustainably high returns including ESG factors and seeks to engage with company management teams as part of this.
- The Fund includes tobacco, climate- and weapons-related exclusions, the details of which may be found in the Fund's Restriction Screening policy on the Company's website ( [www.morganstanleyinvestmentfunds.com](http://www.morganstanleyinvestmentfunds.com) and [www.morganstanley.com/im](http://www.morganstanley.com/im) ).
- The Fund will measure its performance against the S&P 500 Index (the "Benchmark"). The Fund is actively managed and is not designed to track the Benchmark. Therefore, the management of the Fund is not constrained by the composition of the Benchmark.

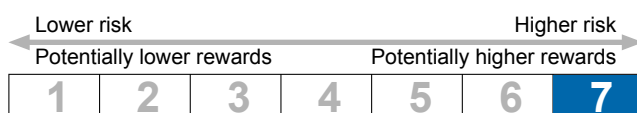
##### Other Information

- The Fund may invest up to 30% of its assets in investments that do not meet the above criteria. The Fund may invest up to 10% of its assets in China A-Shares via Stock Connect.
- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets. They rely on other companies to fulfil contractual obligations and carry more risk. Refer to the prospectus ('Financial Derivative Instruments' section) for more details.
- This is a currency hedged share class. It aims to reduce the impact on your investment of movements in the exchange rate between the fund currency and the share class currency.
- Income will be included in the value of your shares.

##### Buying and selling shares

- Investors may buy and sell shares on every full banking business day in Luxembourg.

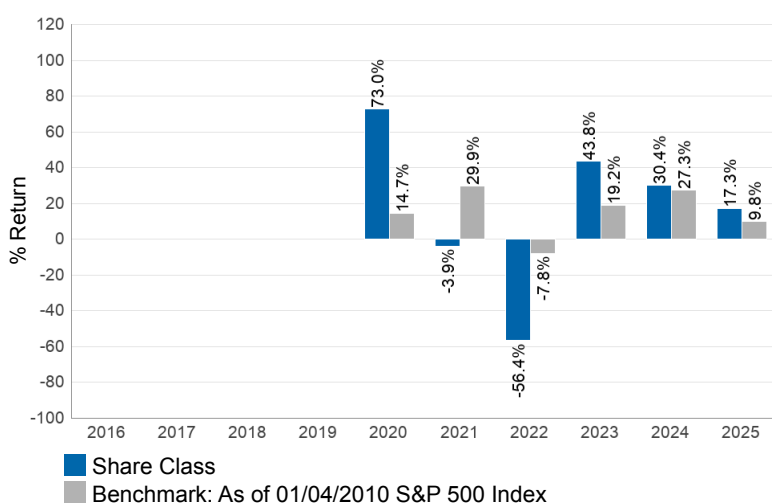
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
