OBJECTIVES AND INVESTMENT POLICY

Objective

- To provide an attractive rate of relative return whilst integrating ESG characteristics and taking into account the long-term global warming objectives of the Paris Agreement.

Main Investments

- At least 70% of the Fund's investments will be in fixed income securities (e.g. bonds).

Investment Policy

- To invest in Euro denominated corporate and non-government bonds that meet the Fund's ESG criteria.
- As an essential and integrated part of the research process and through engagement with issuers, the Investment Manager incorporates an assessment of sustainability related risks and opportunities into the assessment process. The Fund utilises a quantitative and qualitative environmental, social and governance ("ESG") process that applies the Calvert Principles for Responsible Investment. In doing so, the Fund promotes environmental sustainability and resource efficiency, equitable societies and respect for human rights, in addition to accountable governance and transparent operations.
- The Fund includes climate- and weapons-related exclusions alongside other sector/industry restrictions, including gambling, tobacco and companies associated with severe ESG controversies. - The Fund will measure its performance against the Bloomberg European Aggregate Corporate Index (the "Benchmark"). The Fund is actively managed and references

the "Benchmark" for the purpose of maintaining a lower carbon intensity than that of the Benchmark. While the Fund will generally hold assets that are exposed to the Benchmark, it can invest in such components in different proportions. Hence, there are no restrictions on the extent to which the Fund's performance may deviate from the ones of the Benchmark.

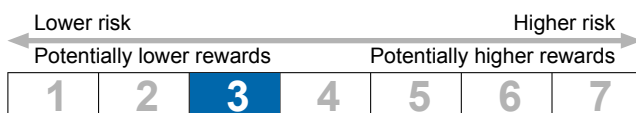
Other Information

- The Fund may invest up to 30% of its assets in other fixed income securities that do not meet the above criteria, for example bonds not issued in Euro. The Fund may invest up to 10% of its assets in securities acquired on the China Interbank Bond Market.
- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets. They rely on other companies to fulfil contractual obligations and carry more risk. Refer to the prospectus ('Financial Derivative Instruments' section) for more details. In relation to this Fund, "Sustainable" means that the Investment Adviser integrates ESG considerations in its investment decision-making.
- The Fund will not invest in any securities that are rated below B- (or below BBB- in the case of ABS, including MBS) by S&P or equivalent. The fund may continue to hold bonds which have had their rating lowered up to a maximum total exposure of 3% of the Fund's Net Asset Value but will sell any bonds that have not been upgraded to a rating of at least B- within six months of its downgrade.
- Income will be included in the value of your shares.

Buying and selling shares

- Investors may buy and sell shares on every full banking business day in Luxembourg.

RISK AND REWARD PROFILE

This rating does not take into account other risk factors which should be considered before investing, these include:

- The value of bonds are likely to decrease if interest rates rise and vice versa.

- Issuers may not be able to repay their debts, if this happens the value of your investment will decrease. This risk is higher where the fund invests in a bond with a lower credit rating.

- There may be an insufficient number of buyers or sellers which may affect the Fund's ability to buy or sell securities.

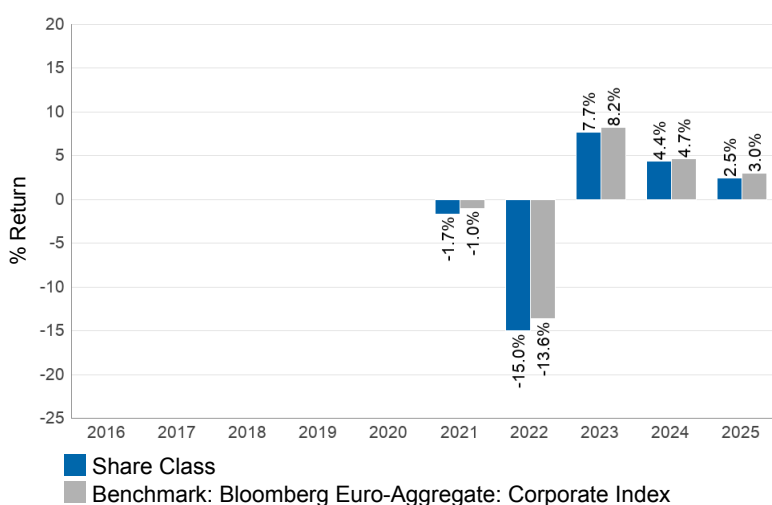
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
