OBJECTIVES AND INVESTMENT POLICY

Objective

- To provide an attractive rate of total return.

Main Investments

- At least 70% of the Fund's investments will be in fixed income securities (e.g. bonds).

Investment Policy

- To invest in lower rated bonds, including zero coupon bonds and deferred interest bonds, from a range of issuers operating in the US. These bonds usually offer a higher yield than higher rated bonds. For this Fund, lower rated bonds are defined as being rated lower than BBB- by S&P or Fitch; or Baa3 by Moody's.
- As an essential and integrated part of the research process and through engagement with issuers, the Investment Adviser incorporates an assessment of sustainability related risks and opportunities into the assessment process.
- The Fund includes tobacco, climate- and weapons-related exclusions, the details of which may be found in the Fund's SFDR Website Disclosure on the Company's website (www.morganstanleyinvestmentfunds.com and at www.morganstanley.com/im).
- The Fund will measure its performance against the ICE BofA U.S. High Yield Index (the "Benchmark"). The Fund is actively managed and is not designed to track the Benchmark. Therefore, the management of the Fund is not constrained by the composition of the Benchmark.

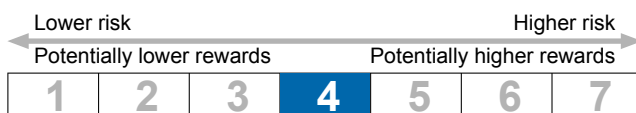
Other Information

- The Fund may invest up to 30% of its assets in other fixed income securities that do not meet the above criteria, for example higher quality bonds.
- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets, for investment or efficient portfolio management purposes. They rely on other companies to fulfil contractual obligations and carry more risk. Refer to the prospectus ('Financial Derivative Instruments' section) for more details.
- Income may be paid quarterly in cash or additional shares.

Buying and selling shares

- Investors may buy and sell shares on every full banking business day in Luxembourg.

RISK AND REWARD PROFILE



The risk and reward category shown is based on historic data.

This rating does not take into account other risk factors which should be considered before investing, these include:

- The value of bonds is likely to decrease if interest rates rise and vice versa.
- The value of financial derivative instruments are highly sensitive and may result in losses in excess of the amount invested by the Sub-Fund.
- Issuers may not be able to repay their debts, if this happens the value of your investment will decrease. This risk is higher where the fund invests in a bond with a lower credit rating.
- The fund relies on other parties to fulfill certain services, investments or transactions. If these parties become insolvent, it may expose the fund to financial loss.
- Sustainability factors can pose risks to investments, for example: impact asset values, increased operational costs.
- There may be an insufficient number of buyers or sellers which may affect the funds ability to buy or sell securities.

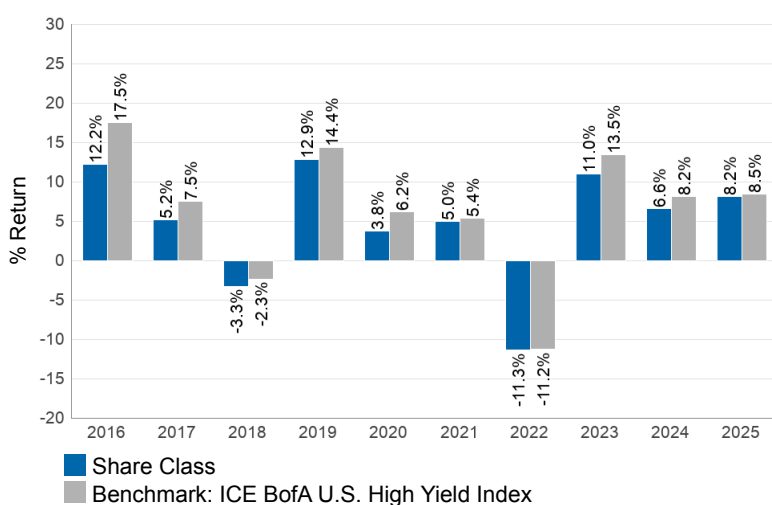
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.

Therefore, the Fund's performance between 1st April 2022 and 30th August 2023 was achieved under different circumstances.
- Past performance is based on the performance of Eaton Vance International (Ireland) Sustainable US High Yield Bond Fund that was absorbed into this Fund on 2 December 2022.
