The fund is managed by MSIM Fund Management (Ireland) Limited, part of the Morgan Stanley group.

### OBJECTIVES AND INVESTMENT POLICY

#### Objective

- To provide an attractive total return, with low correlation to traditional asset classes, and a target annualised volatility of 8%.

#### Main Investments

- The Fund will gain exposure to UCITS-eligible financial indices via financial derivatives, e.g. total return swaps.

#### Investment Policy

- To gain exposure to a diversified set of investment strategies across different asset classes, including but not exclusively Equity Securities, Fixed Income Securities, Cash Equivalents, Currencies and Commodities.
- Investment Strategies the fund may gain exposure to include (without limitation) Value Strategies, Carry Strategies, Curve Strategies, Trend/Momentum Strategies and Mean Reversion Strategies. The allocation to different strategies will be based on a systematic process set by the Investment Adviser, considering risk and returns.
- The Fund will measure its performance against the HFR Asset Manager Risk Premia Index. The Fund is managed according to a systematic strategy, and does not seek to track the Benchmark. Hence, there are no restrictions on the extent to which the Fund's performance may deviate from the Benchmark.

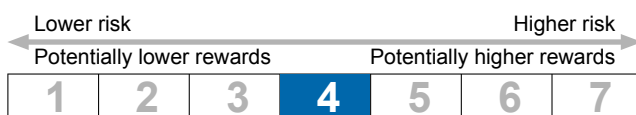
#### Other Information

- For temporary defensive purposes, the Investment Adviser retains discretion to reduce exposure to UCITS-eligible indices and invest the Fund's assets in Treasuries and Cash Equivalents.
- This is a currency hedged share class. It aims to reduce the impact on your investment of movements in the exchange rate between the fund currency and the share class currency.
- Income will be included in the value of your shares.

#### Buying and selling shares

- Investors may buy and sell shares on any day that is a full banking business day in both Luxembourg and the United States.

### RISK AND REWARD PROFILE
